

The 14th Annual Irish Echo Labor Awards are set for the Edison Ballroom in Manhattan on Friday evening, September 6.

The gathering will honor eleven labor leaders for their varied, but in every case distinguished, service to the cause of labor in America. The keynote speaker for the evening will be New York State Comptroller Tom DiNapoli.

It's fair to say that, over the years, the contribution of the Irish in America to the cause of labor has been nothing less than immense.

Indeed, it could be argued that the American labor movement would not exist at all in its current form without the efforts of standout Irish men and women, champions of labor all, down those years.

His execution by the British in 1916 robbed Ireland and the USA of one of the giants of the Labor Movement.

Connolly understood the importance of workers standing together, united against injustice and oppression.

He famously wrote: 'The cause of Labour is the cause of Ireland; the cause of Ireland is the cause of Labour.'

This is especially important in the context of the partition of Ireland by the British, the growing demand that for the full delivery of the Good Friday Agreement and the increasing support for a United Ireland.

I applaud all those being recognised but want to give a particular shoutout to two honorees: Mary Claire Breslin, the only women honoree tonight who has been a teacher and a union activist in New Rochelle for 32 years; And our sole Boston representative Richard MacKinnon Jr. President of the Professional Fire Fighters of Massachusetts.

Like all of our honorees, they are true heroes committed to helping their fellow-workers.

Thank you all for your solidarity and support.

#### RICHARD MacKinnon Jr.

City and State: Dennis. MA.

Current Company and Position: President of the Professional Fire Fighters of Massachusetts; Firefighter/Paramedic Whitman Fire Department.

Family: Long time girlfriend Erin Kate Lynch; Daughters Rosemary Margaret MacKinnon and Lillie Beth MacKinnon

First Job: My very first job was a dishwasher at St. Joseph's Manor in Dorchester. It was a Catholic nursing home in Dorchester, MA. I was 13 years old. The schedule was one week on and one week off. Monday to Friday was 5-9 pm and on Saturday and Sunday we worked breakfast, lunch, and dinner with breaks in between.

I liked working and having my own money. It was also a good group of people to work with, some were my age and a lot were older. The cooks were a diverse crew as well. Tim was a WWII Veteran that was also a cook during his time in the military.

Another woman Barbara, was a mother from our neighborhood and her children all worked part time there too. Then there was Al, a very large scary man that didn't say much but when he did was profound. He was Jamaican and very strict and stern but always fair. He was the head cook. I remember him having a big white Cadillac with Gucci interior. I thought that car was great! Sr. James Francis was the Boss, with a capital "B"! She ran everything and was good at it. I loved interacting with the elderly residents and listening to their stories. I eventually moved up to become waiter which I am proud to say was the first male on the wait staff. I worked there for several years.

What it taught me: My first job taught me how fortunate I was to be working at a young age. 13 was an unusual age and was a little young than the normal staff at the nursing home. My father knew Sr. James Francis well so she made special accommodations so I could be hired. I was grateful to have the job and it was a great experience early on in life. The job taught me to listen and be empathic toward others. It also taught me to respect elders and that so much can be learned from them. Having a job that young also taught me the responsibility of work. There were events and things I could not do because of work. Since that first job I have had many others but I have never not had a job or multiple jobs since then. I am now 51 years old and doing what I was meant to do. I love the profession I am part of and the first job as a dishwasher help create the foundation and structure to be successful.

Best advice you could give someone starting out: is to take care of yourself first. That doesn't mean be selfish. It means take care of yourself spiritually, mentally, physically, and whatever else is needed to take you the best person you can be. If you aren't well, then you will not be able to take care or serve anyone else. Take time for yourself, schedule it in to your daily calendar if you need to. I learned the hard way having a heart attack at age 50. I was lucky and caught things early and thanks to that I am currently in the best shape of my life.

I would work literally from the time I got up to the time I went to bed. My union job would take up most of my time or I would allow it to, and I was still working shifts



on the firehouse which I love. I look at things differently now and take the time to pray, mediate and workout and if I am better I can better.

I would also tell someone starting out to stay real and not take things or yourself seriously. Be empathic, you never know what someone is dealing with or going through. I try living by the four agreements: Be impeccable with your word, Don't take anything personally, Don't make assumptions, and Always do your

Never be afraid to change or make decisions. You will make wrong ones but go with your gut and make them. You will never please all people but do what you think is right and respect everyone until they give you a reason

Who is your hero and why? My hero is absolutely my dad. I admire so much about him and strive to be like him. He is where I learned my spirituality, my work ethic, and a lot of who I am. He set a great example of what it means to have faith in God, faith in people, and how to be just a nice guy. Growing up he always worked 2 or 3 jobs to support our family of my mom and 3 siblings. He would go from one job to the other often with no sleep. He worked as a Boston Firefighter which meant working nights and days, and then work at funeral home and wash windows. He never complained, just worked, and at the same time making time for us. My strong faith is directly from him. He taught us to put God first and everything else will come. God, family, work was what he lived by. I remember him telling me he offers everything up to Mary the Blessed Mother and she always takes care of him. He prays the rosary every day and takes part in regular adoration of the Blessed Sacrament. Through his example it caused me to strengthen my faith and relationship with God. I have a

greater appreciation for what I learned when I was younger, like the importance of prayer in my life and surrendering to God. I knew from a very young age that I wanted to be firefighter. When we were kids my mother would bring us into the firehouse to see him when he would double and triple shifts knowing that would be the only way for us to see him for the couple days. I remember the "big thing" was when I turned 13 years old he would allow me to spend the night at the firehouse and go on the runs. It was a natural fit for me, I loved every second of it. The men we worked with in the firehouse were family and still are to this day. Then when I got on the job I couldn't stand on the side and watch things that I knew were wrong go by. That is why I got involved in the union and haven't looked back since. The union is about taking care of people and I thank God every day I get to do it.

ich MacKinnon Jr. is a third-generation firefighter, serving 24 years as a Firefighter/Paramedic in the town of Whitman. He was elected President of the Professional Firefighters of Massachusetts (PFFM) on October 22, 2016.

MacKinnon has served in an elected capacity within Whitman Firefighters Local 1769 since 2001. In 2001, he was elected to the Bargaining Committee, and as an At-Large Member. In 2009, he was chosen to serve on the Whitman Fire Department Ambulance Committee on Rules and Regulations. From 2010 - 2016, he served as Union President.

In 2011, Rich was elected to the PFFM Executive Board as the District 1 Vice President, servicing 32 locals within the organization's 12,000 membership. While on the PFFM Executive Board, he has served on several other boards. In 2011, he was appointed by Governor Patrick to be one of two PFFM representatives on the state Joint Labor Management Committee (JLMC) where he represented labor on arbitration panels to settle contracts. He also serves on the PFFM's EMS Committee as the sitting E-Board Member and is Co-Chairman of the PFFM Constitution and By Laws Committee. In 2013, MacKinnon was named Chairman of the Professional Fire Fighters of Massachusetts Funeral Committee which assists locals in the handling of line of duty deaths, active member deaths, and retiree deaths across the

In 2011, Rich was appointed to the IAFF Standing Committee on EMS representing the Third District of the IAFF which includes Vermont, Maine, New Hampshire, Massachusetts, Rhode Island, and Connecticut. In 2012 and 2013 he was selected to serve as the IAFF Principal Member on the NFPA Technical Committee on EMS and the NFPA EMS 450 Standard Committee. He continues to be active in the IAFF on a variety of committees.

In 2021, he was appointed to a five-year term on the Public Employee Retirement Administration Commission (PERAC) and serves as a commissioner. He currently also services on the Massachusetts Fire Services Commission, the Massachusetts AFL-CIO Executive Board, the Massachusetts Fallen Firefighters Memorial Board, the Governor Maura Healy Labor Advisory Council, the Advisory Board of Mascon Medical, and the Board of Directors for On-Site Academy.



First Job: After graduating DeWitt Clinton High School, I worked at a gas station and auto repair shop. I started out pumping gas and doing road service. I wanted to be a mechanic. A wonderful man and senior mechanic at the station, Ed Lowe, helped me every day and taught me everything he knew about the job. This helped me enormously in securing my career with the MTA-MABSTOA as a bus maintainer. What it taught me: My experiences in my first job convinced me that one should always help your co-workers, and

always be willing to pass along your knowledge and experience to those coming onto the job. I found out that I liked helping others on the job, and it formed the basis of my career as a union officer fighting for the rights of my brothers and sisters in transit.

Best advice you could give someone starting out: Go to work every day. Give the employer a fair day's work for a fair day's pay. Respect your supervisors and your co-workers, and the respect will be

returned to you two-fold. Always support your union. Attend union meetings and be willing to get involved. Finally, always pass your knowledge and expertise along. When you see one of your coworkers doing a job the way you showed them, it will be a satisfying reward.

Who is your hero and why? Definitely my dad, James Whalen, Sr. He was a wonderful father, loving husband and courteous gentleman to all. He worked hard as a truck driver to provide for the family, and he came home every night after work to have dinner with us and my mother. He raised me and my two brothers as respectful young men that we carried with us throughout our lives.

ames Whalen is International Vice President of the Transport Workers Union of America, and Director of the TWU Local 100 Retirees Association. He has also served as a Trustee and Member of the Pension Investment Committee for the MTA-MABSTOA Pension Trust for the past 25 years. During that time, he has helped transform the fund from one with heavy unfunded liabilities to a trust that will be 100 percent funded in the next two years. James was first elected to a union position in 1986 as Maintenance Vice Chair at the Kingsbridge Depot in Manhattan. He was elected to numerous other union positions and also served as a full-time organizer for TWU Local 100.

He was elected to the TWU International Executive Board in 1997, to the Executive Council in 2001 and as Vice President in 2005, a position he still holds

He is a life-long resident of the Bronx, NY where he shares his home with his wife Ester, who was born on Easter in the beautiful town of Kenmare, County Kerry, Ireland. He traces his strong Irish roots to Armagh in Northern Ireland.

What it taught me: The fast paced environment of the family restaurant business was a spring board for my future career endeavors as it honed valuable skills such as communication, teamwork and understanding the value of fair treatment in the workplace. These skills were invaluable in fostering collaboration and building strong relationships in the construction industry.

Best advice you could give someone starting out: Build strong relationships by communicating, actively listening and learning from different perspectives. Having a strong work ethic and demonstrating your dedication and inspiring other workers is a key to your future success. The construction industry has a wealth of knowledge that is passed down from prior generations. By listening to more experienced workers, you will learn valuable information that will help you develop your skills and problem solving techniques.

Who is your hero and why? My parents are my heroes. My parents emigrated from Ireland (counties Galway and Fermanagh) leaving everything they knew to build a new life for themselves and our family. They worked so hard to give my brother and I a good life and future. Both of my parents were active union members (32 BJ of the SEIU for my mother and the Carpenters Union for my father). The sacrifices that they made to provide for us instilled a fire in me to work hard and to be able to give more to my family.

orn and raised between the bustling streets of New York and the vibrant landscapes of Ireland, Tom Costello has always possessed a spirit of adventure and a deep connection to his roots. He honed his academic skills starting at St. Mary's College in Galway and further developed his athletic prowess on the hurling pitch. He claimed two coveted Connacht championship medals which not only showcased his talent and dedication to the sport but also developed his teamwork and leadership skills. Driven by a desire to explore new horizons, he returned to the US. Tom received his bachelor's degree from Fordham University and master's degree from Cornell University in Labor Studies. He also continued participating in athletics proudly adding two NY championship medals to his collection, playing for the Rangers and Sligo Gaelic

During the same time over 45 years ago, Tom joined the Carpenters Union. First Job: Intern/Clerk US Drug Enforcement Administration.

What it taught me: While I had odd jobs as a child, my first real job was for the DEA. I learned the importance of attention to detail, networking, and being passionate about what you do.

Best advice you could give someone starting out: Be a yes person. Dedicate your time to what you are doing. If it be union work or police work, there is no greater teacher than experience and time. The more you are exposed to the more experience you will gain and as you get more time on the job you can look back and see how far you have come. Take that extra shift, do that undesirable detail, volunteer to help out and you will gain more experience.

Who is your hero and why? My father and mother. My father was a police officer for more than 20 years who balanced work and family but always put the family first. My mother was always there for not just her children but all her family and friends. Together they showed me and my sisters the importance of respect, family, and never giving up.

at was raised in Orangetown, NY by James and Jane Ann Casey along with his two sisters Sinead and Meghan. Pat graduated from Tappan Zee High School in 2007 where he got his



competitive edge as a captain of the Varsity Basketball team and earned many honors and awards to included 1st Team All county. What it taught me: What it takes to keep a physically demanding job that starts early in the morning. How to work safely and best protect myself from the elements, mostly the hot sun. Working with blacks, Latinos and eastern Europeans, I learned that hard physical labor effects everyone the same, and that the respect and reward for those who perform such labor should be the same for all, regardless of what they look like

Best advice you could give someone starting out: Respect the experience of those who have been around longer than you, it's worth more than anything you'll find in a book. Ask questions, you'll be surprised how many people are happy to help.

Who is your hero and why? As the father of our nation, George Washington stepped down as President after his second term. establishing the precedent that the Presidency is not a lifetime appointment. The peaceful transfer of power is what made America great and unique in the world, and it so easily could not have come about had he not set the standard.

In July 2023 David Bolger became the business manager of the 17,000 member Mason Tenders District Council of Greater New York and Long Island. The road he traveled to reach his current position within the Laborer's International Union of North America began nearly 40 years ago, when Dave joined Laborers Local 13 and began his career as a Laborer. Dave Bolger represents a new generation of labor leader, dedicated to organizing, social justice and improving the lives of the members of the union

Born on Long Island into a bi-lingual family, Dave's father's job took the family to different parts of the United States and the world. In 1970 the family returned to Queens, New York, which has been Dave's home ever since. Bolger entered the construction industry in 1985, following a series of jobs outside the industry. Most of those jobs were union jobs, and exposed Dave to the important role that unions played in protecting workers, and promoting worker's rights and respect on the job. Working as a general laborer, Dave soon began his rise through the ranks of the local union, from shop steward, to business agent, to acting business manager, to elected officer.

In 1998 during the period that the Mason Tenders District Council and its affiliated unions were reconfigured, Dave was appointed acting business manager of House Wreckers Local 95, steering the local through bankruptcy, until it was finally merged with the newly chartered Local 79. Recognized by the leadership for the role he played in successfully leading Local 95, Dave was hired as a field representative of the Mason Tenders District Council

For the next 25 years, Bolger became an in-house advocate for thousands of members. His efforts resulted in the Trust Funds collecting millions of dollars on behalf of thousands of members. Members came to Dave to help them receive the benefits they had earned. Dave's ability to communicate with the membership in both English and Spanish, served him well as he developed a relationship with the members based on mutual respect and trust.

Time and time again, Dave was called upon to serve in different roles, all in the name of protecting the union and the members' right. Whether it was serving as acting business manager, an election judge, or a deputy trustee, Dave remained true to his lifelong professional commitment of serving the members of his union.

Perhaps his greatest challenge came in the immediate aftermath of the 9-11 attacks on the World Trade Center. Dave was tasked with supervising and running the Laborers' command center during in the massive clean-up. From September 13. 2001 until the official clean up ended on May 30, 2002, Dave headed the command center, where lead and fit tests were administered on a daily basis, all necessary personal equipment was distributed to members, and given the magnitude of the job and emotional issues the members faced, counseling and mental health support was provided to all who asked for help.

In addition to leading the Mason Tenders District Council Bolger serves as a member of the Mason Tenders District Council Political Action Committee, as well as a trustee of the New York State Laborers' PAC, and the New York State Laborers' Health & Safety Fund, as well as the NYS Organizing Fund. He serves as a trustee of the Mason Tenders' District Council Trust Funds, the MTDC Scholarship Fund, the Mason Tenders' Training Fund and the Laborers' Eastern Region Organizing Fund, LEROF. Additionally, Dave is an executive board member of the **Building & Construction Trades Council of** Greater New York.

#### Irish Echo Labor Awards

"I have been lucky to have been surrounded by inspiring, loving people like Brendan Archbold (RIP), a friend I will miss forever."

Maybe it was reading that sentence that led me to write about the full-time union representative involved in the Dunnes Stores strike that began in July 1984 and played out until the Irish government banned in 1987 the sale of South African goods.

The line is from Mary Manning, one of the leaders of the famous action, in her terrific first-person account entitled "Striking Back," written with journalist Sinead O'Brien, and published in 2017.

Brendan, who died in 2014, was my grandmother's nephew. So, seeking more information, I interviewed my uncle Paul Mulhern, his first cousin and a lifelong friend. But then late in 2022, I found information about Paul's father, my grandfather, while idly looking through the Irish Newspaper Archives in a public library in Independence, Mo. It was about a strike in 1937, and a picket-line incident that led to Grandad going to prison.


All this ended up as one longish story in last year's supplement, but I ran out of space when it came to Brendan, and didn't cover perhaps some of what needed to be said, including passing on some of what's reported about him in "Striking Back."

In it, Manning says, "Brendan Archbold was the antithesis of this [Dunnes] management which lacked any form of compassion. He was a complete rarity in the male-dominated world of the 1980s in that he genuinely treated everybody equally. Whether you were male, female, young or old, he was a man who always had time not only to listen, but to act quickly to rectify a situation. Anyone who worked the more menial jobs in Dunnes benefited his unwavering from perseverance for their rights and for that reason he had the complete trust of every one of us on the picket line."

One situation was the outright hostility the strikers faced from their fellow workers not on strike: often it came in the form of racial slurs and racially-charged language. Manning remembers that if it hadn't been for Brendan's "steadying presence on the picket line it would already have descended into a fist fight between 'us' and 'them' on several occasions."

Mary Manning says she got to know four "great men" in her life and all were connected to the Dunnes Stores episode: Tommy Davis, the lone male among the 10 strikers; Nimrod Sejake, a South African activist living in exile in Dublin, who was 63 when the strike began; Archbishop Desmond Tutu; and Brendan.

At the time of his death, the trade unionist's exceptional intelligence, his wry wit, his modesty, his great sense of fun, the fact that he was a loving husband and

father got prominently mentioned.

I knew all that already, of course.

What Paul, my uncle, said got missed was just how humble and difficult Brendan's upbringing was. Some of that was due to the disruption of war. George Archbold, his father, worked as ground crew, or an "aircraft man," in the RAF. Granny's two brothers also served during World War II and Grandad, Paul's father, joined the RAF police. The absences took their toll in most families, but in the Archbolds' case made for a very unhappy marriage. George likely preferred the military life away from Dublin and it didn't help that the money he dutifully sent home was too easily squandered by his wife Bertha, Granny's sister.

Much later in the saga, George took out an ad in the newspapers saying he wasn't responsible for his wife's debts.

The children, however — Brendan, his

older brother Michael and their two sisters - "were happy as siblings; they were very supportive of one another," Paul remembered.

The Murrays, my grandmother and her five siblings, were also close. When they married, my Murray great-grandparents were listed as domestic servants; he was a native of County Meath, while she was from Dublin. My grandmother was about 1 and her older sister 5, when the family moved north where my great-grandfather got a job as a groom in stables close to East Belfast. They were there for about 13 or 14 years when serious ethnic conflict broke out. That was in 1922.

The Murrays, now with six children, moved back south to Dublin. In my early childhood in the 1960s, all six were there again, their immigrant adventures and war experiences behind them. I remember they spoke gently with soft Belfast accents, almost, it seemed at times, in a whisper. And some of them had bronchial issues. That was certainly the case with the unmarried sister, the family's designated child-minder. Her parents christened her Mildred; the fourth generation, mine, called her Millie.

"Bertha and Mildred were thick as thieves," Paul said of a pair I remembered fondly as gentle souls, not being aware of such an alliance.

As a teen, Paul would go across the city to Finglas to spend time with Michael, who was four years his senior, and Brendan, who was three years younger. When Tommy, a friend of Brendan's from school in Finglas who was born on the same day in 1947, joined them, they had teams to play football. The yard in Merville Dairies, where the Archbolds were the gatekeepers, was their venue. Later with the introduction of battery-powered milk trucks, they rode around on them as if in the dodgems in Bray.

Paul joined An Slua Muirí, now known as the Naval Reserve, in 1960. He was two years underage at 16. He attended the annual two-week camp, got paid for it and also received a generous annual gratuity. Seeing how much fun he was having, Brendan and Tommy joined up in the mid-

Meantime, long before he was required to do any state exam, Brendan had fallen through the cracks of the education system and never returned.

From his early teens on, he worked in a variety of jobs in Dublin and beyond. His adult breakthrough came with a position in a well-known security company, which he got in part because he had acquired a driver's license.

My mother was very proud of the fact that she taught Brendan how to drive (other people may have given him lessons, too, but not in her version), because that led to the job and his involvement in a subsequent industrial action. There was a sit-in and he was carried out by gardaí.

"That's when he was talent-spotted by the trade union movement," Paul said.

Out of the Slua Muirí episode Brendan's best friend Tommy became a professional-level sailor; Tom Lawlor achieved most fame, though, as a top press photographer, joining the Irish Times staff in the early 1970s. Tommy and Paul are friends to this day.

The Murrays' third generation thrived in careers such as nursing and firefighting and a few did very well in the business world. But Brendan was the star as an admired leader in the labor movement. His cousin and friend Paul wonders just how far he might have gone if he'd gotten an education early and been given a chance to go on to university. His two sons, though, have pursued their degrees and professional training and are doing very

Since 1998 the armed conflict in Ireland has ceased. But the British policy of division by partition remains. Since 2010 five Prime Ministers have threatened that peace by ignoring the obligations and undermining the principles of the GFA. The real purpose of Britain leaving the EU was: (1) to escape the EU Court of Justice; (2) to ignore Article II of the EU Constitution to protect life; and (3) to block EU rules for preventing and prosecuting British money laundering. Such activity supports illegal arms, drug, and human trafficking, and renders ineffective U. S. sanctions imposed on nations like Iran and Russian oligarchs.

American political leaders have expressed bi-partisan support for the GFA as well as disappointment with British actions to wit, the obstruction of the Irish unity poll; the adoption of the N. I. Legacy Law to bury crimes of British police and security services; and the frequent unilateral suspension of political institutions. Prime Minister Starmer wishes to repeal the Legacy Act and Foreign Secretary David Lammy has chastised Conservatives for their endless 'rows' with America over Ireland. The unilateral action of Irelands partition and the aftermath of battalioned despotism and the disastrous folly and economic harm of Brexit certainly suggests the time for half-measures like perfecting partition are well and truly over.

The 2021 New US-UK Atlantic Charter depicts concepts of democracy, rule of law, transparency, and respect for human rights to which both nations are committed. The GFA was the first step in the Irish peace process. The mendacity of the British Conservatives has denied, delayed, or dismissed any real further progress. Britain needs a recovery from Brexit if it is to restore the prosperity it once enjoyed when an EU member. That recovery depends, in part, on ending the expensive subvention that props up the 6 Irish county region created by partition and on negotiating a new US-UK trade deal. It is increasingly clear that both the US, the EU and many nations would welcome and support the real progress of reunification.
